

Please allow this correspondence to confirm that George Leber, M.D. has completed a total of 1,080 of clinical training hours under by supervision. During the course of his training, Dr. Leber completed 500 hours working in the nuclear cardiology lab to include:

- A. Examining patients and reviewing their case histories to determine their suitability for radioisotope diagnosis, limitations, or contraindications.
- B. Selecting the suitable radiopharmaceuticals and calculating and measuring the dosages.
- C. Administering dosages to patients and using radiation shields.
- D. Collaborating with the authorized user in the interpretation of radioisotope test results and patient follow-up.

The remaining 500 hours of clinical training was completed in the following areas:

- A. Ordering, receiving and unpacking radioactive materials safely and performing the related radiation surveys.
- B. Checking survey meters for proper operations.
- C. Calibrating dose calibrators and diagnostic instruments and performing checks for proper operations.
- D. Using procedures to contain radiation spills of byproduct material and using proper decontamination procedures.

In compliance with regulations addressed in 35.290, Dr. Leber completed a minimum of 700 hours of academic and clinical training. Please note, that Dr. Leber completed 80 hours of his training in a formalized academic setting. A certificate attesting to the completion of his training has been attached for review. Please refer to this document for details.
