REGARDING THE ADDITIONAL SECURITY MEASURES FOR ACCESS  
AUTHORIZATION AT THE RANCHO SECO ISFSI**

On August 18, 2004, the NRC issued an Order for additional security measures associated with access authorization at the Rancho Seco Independent Spent Fuel Storage Installation (ISFSI). Section IV of the Order states:

*In accordance with 10 CFR 2.202, a licensee may request a hearing on this Order, within 20 days of the date of the Order. Where good cause is shown, consideration will be given to extend the time to request a hearing.*

As required by Section III.C.1 of the Order, our response includes the proposed dates for completing any additional actions that may be required. Because of the unique nature of the situation that precipitated the issuance of the Order and the lack of any implementing guidance, we are not certain that our response and proposed implementation schedule are adequate for meeting the NRC's intent for complying with the requirements in Attachment 1 to the Order. Hence, we are not able to determine whether it is necessary to request a hearing until the NRC notifies us that our response satisfies the intent of the requirements in the Order.

Therefore, in accordance with Section IV of the Order, Rancho Seco requests an extension of time to file a request for a hearing until 20 days after the NRC has informed us of their determination regarding the acceptability of our response.

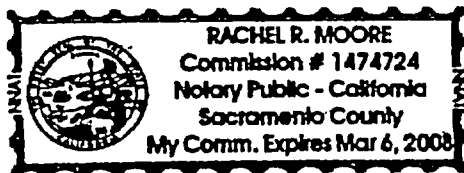



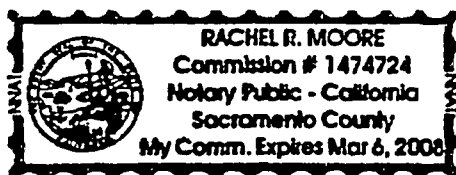
