The purpose of this modification is to provide incremental funding in the amount of \$25,000.00, thereby increasing the obligated amount from \$559,966.00 to \$584,966.00. Accordingly, the contract is modified as follows:

Under Section B.4 CONSIDERATION AND OBLIGATION—COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), Paragraph (c) is deleted in its entirety and replaced with the following:

“(c) The amount currently obligated by the Government with respect to this contract is \$584,966.00.”

All other terms and conditions of this contract remain the same, including the contract ceiling amount of \$935,425.00.
