Dear Mr. Abeywickrama:

This confirms verbal authorization provided to you on June 22, 2005, with a temporary ceiling of \$30,000.00.

In accordance with the Section G.4, Task Order Procedures, of the subject contract, this letter definitizes Task Order No. 2. This effort shall be performed in accordance with the enclosed Statement of Work.

Task Order No. 2 shall be in effect from June 22, 2005, through June, 21, 2006, with a cost ceiling of \$58,031.00, which is inclusive of the \$30,000.00 temporary ceiling authorized on June 22, 2005. The amount of \$53,239.00, represents the total estimated reimbursable costs, and the amount of \$4,792.00, represents the fixed fee.

The amount presently obligated with respect to this task order is \$30,000.00, of which the amount of \$27,523.00 represents the reimbursable cost, and the amount of \$2,477.00 represents the fixed fee.

In accordance with FAR Clause 52.232-22 - LIMITATION OF FUNDS, the contractor is not obligated to continue performance under this task order or otherwise incur costs in excess of the amount obligated, until the Contracting Officer notifies the contractor in writing that the obligated amount has been increased. In absence of such notification by the Contracting Officer, the Government is not obligated to reimburse the contractor for any costs in excess of the obligated amount specified herein.
