Dear Ms. Dandois,

The subject invoice (copy enclosed) was received by Westinghouse Electric Corporation from the USNRC. Although it is not clear from the invoice what this billed amount is for, it possibly is related to a post-cleanup inspection of our closed Bloomfield, New Jersey former Westinghouse Lamp Plant facility performed by ORAU for the USNRC Region 1 Office. In order for us to process an invoice of this magnitude for payment we require some backup information. Therefore, I request that you forward us the following:

- 1) An explanation/scope description of the service performed for which we are being invoiced.
- 2) Backup details on the cost buildup (such as labor hours/costs by category and task, and material and travel costs as appropriate).
- 3) If this invoice is for the inspection discussed above, we would ultimately like to have a copy of the final report generated as a result of the inspection.

By receipt of a copy of this letter, we hereby ask Mr. John D. Kinnemann of the USNRC Region 1 Office to assist your office with this request. Upon receipt of the requested descriptive and backup information, we will review the invoice for payment within 30 days of receipt of the additional information.
