SUBJECT: SUMMARY OF NOVEMBER 16, 2005, THE MEETING WITH PACTEC  
AND WASHINGTON TRU SOLUTIONS ON TRUPACT-III PACKAGE  
(DOCKET NO. 71-9305, TAC NO. L23827)

On November 16, 2005, representatives of the Nuclear Regulatory Commission (NRC), Packaging Technology (PacTec), and Washington TRU Solution (WTS) held a pre-application meeting to discuss the redesigned TRUPACT-III transportation package which had been withdrawn by PacTec in August 2004. This was the second pre-application meeting on the redesigned TRUPACT-III package.

The redesigned TRUPACT-III package is a shorter package which can be transported within a legal weight highway shipments limit. The package is rectangular in shape and is the size of a 14 foot ISO container (14 ft x 8.2 ft x 8.7 ft). The package provides a single containment system that is designed to transport oversized boxes of contact-handled transuranic waste materials consisting of solid and solidified materials (similar to the TRUPACT-II, Certificate of Compliance No. 71-9218). Two stainless steel thin (i.e., 8 mm) walls with 4 mm stiffeners in between are used for the construction of the containment vessel.

PacTec presented the results of engineering tests which were performed on the original half-scale model for TRUPACT-III. They also discussed the plan for certification tests. PacTec's new date for certification test is July 2006 and submittal of an application to the NRC is October 2006.

WTS presented a description of the proposed contents for TRUPACT-III packaging, and discussed a methodology for qualifying unvented waste containers with flammable gas content exceeding the 5% limit for transport in TRUPACT-III packagings.

No regulatory decisions were made at the meeting.
