The US Army Research Laboratory (ARL) requests the amendment of Nuclear Regulatory Commission (NRC) Byproduct Material License Number 19-12056-02 removing Humboldt Model 5001 Nuclear Moisture/Density Gauge Serial Number 3618 from our authorized possession limits.

Gauge Serial Number 3618 containing 10 mCi of Cs-137 Serial Number 9868GQ and 40 mCi of Am-241 Serial Number NJ03911 has been returned to Humboldt (the manufacturer) for disposal. A copy of source acceptance letter is enclosed.
