Subject: Notification of Intent to Decommission Ann Arbor Satellite Facilities (License Numbers 21-01443-06 and 21-32115-01)

Dear Ms. Pelke:

This letter is to notify you that Pfizer has decided to cease licensed activities and permanently decommission three Ann Arbor satellite facilities. Specifically, the following facilities will be decommissioned:

- Domino Farms Facility (license No. 21-01443-01) located at Building V, Domino Farms, 24 Frank Lloyd Wright Drive, Ann Arbor, MI.
- Esperion Therapeutics Facility (license No. 21-32115-01) located at 3621 South State Street, 695 KMS Place, Ann Arbor, MI.
- Ellsworth Road Facility (license No. 21-32115-01) located at Suite V, Cayman Chemical Building, 1180 East Ellsworth Rd., Ann Arbor, MI.

Each facility will be decommissioned for unrestricted use and returned to their respective landlords. This will require removal of the Domino Farms Facility from the main campus license and termination of license no. 21-32115-01. Licensed activities at these facilities will be relocated to other licensed Pfizer facilities as part of Pfizer's reorganization and consolidation plan.


Pfizer has procured Chase Environmental Group (Chase) to perform all decommissioning activities. Decommissioning will be conducted under the provisions of the Pfizer radioactive materials license and in accordance with a MARSSIM-based Decommissioning Plan (DP) developed by Chase and approved by Pfizer. A copy of the DP and will be maintained in the license files for NRC review. On-site decommissioning activities at the Domino Farms site are expected to be completed in February 2006. The Esperion and Ellsworth Road sites are

scheduled for decommissioning in the second quarter of this year. I will keep you informed as the project progresses.
