

The purpose of this modification is to incrementally fund this order in the amount of \$72,000.00 increasing the obligated amount from \$248,964.00 to \$320,964.00. Accordingly the contract is modified as follows:

1. Refer to Section B.2, "CONSIDERATION AND OBLIGATION", paragraph (b), first sentence, is deleted and substituted with the following in lieu thereof:

"(b) The amount presently obligated with respect to this contract is \$320,964.00"

2. Section C.1 52.252-2 CLAUSES INCORPORATED BY REFERENCE – FAR clause 52.232-19, "Availability of Funds for the Next Fiscal Year", is revised to read as follows:

"52.232-19 Availability of Funds for the Next Fiscal Year

Funds are not presently available for performance under this contract beyond September 30, 2006. The Government's obligation for performance beyond that date is contingent upon the availability of appropriated funds from which payment for contract purposes can be made. No legal liability on the part of the Government for any payment may arise for performance under this contract beyond September 30, 2006, until funds are made available to the Contracting Officer for performance and until the Contractor receives notice of availability, to be confirmed in writing by the Contracting Officer.
