We wish to amend our byproducts materials license 37-30854-01 to include a name change for our primary location. The current licensee is Central Penn Management Group.

The name is to be changed to – Red Rose Cardiology and the office of Ellen K. Smith, MD, FACC. A name change is requested in conjunction with the renaming of the practice. Lee Meyers remains CEO of CPMG and Central Penn Management Group remains the holding company of the practice.

All personnel, operations, radiation safety program, location (address and exact rooms) remain unchanged. Paul Collura, M.D. will remain the R.S.O. Since the hot lab remains unchanged and the dose calibrator sealed sources remain unmoved, and no Tc-99m or other contamination has been noted in the most recent survey (4th quarter performed 12/07/05) and wipe tests leading up to the date of transfer, we feel no close out survey will be required for this request. Our radiation safety program is unchanged by the requested amendments.

All regulatory-required records of CPMG will be transferred to Red Rose Cardiology including, but not limited to any decommissioning instructions (there are none).

CPMG remains the holding company of the practice and will continue to abide by all constraints, conditions, requirements and commitments assumed at the time of purchase of the practice from PAL Diagnostics in September of 2005.




