Subject: Submittal of Revision 2 to Exelon Generation Company's Early Site Permit Application

Enclosed is Revision 2 to the Exelon Generation Company (EGC), LLC's Early Site Permit application. Revision 2 supports the NRC staff's ongoing review. Revision 2 incorporates the following changes:

- EGC's responses to NRC requests for additional information,
- EGC self-identified corrections to information, and
- NRC identified corrections.

All text and table pages (not just revised pages) are identified as Revision 2 and the differences (from Revision 0) on each text and table page are annotated with single change bars. The differences in Revision 2 (from Revision 1) are annotated with double change bars. The change bars on the List of Figures identify the revised figures, however, the individual figures are not annotated.

Please note that an error was identified in our revised RAI response dated December 21, 2005. On page 4 of 10 of the Enclosure, the minimum lake level for Clinton Lake was incorrectly stated as 277 ft msl. The correct minimum level of 677 ft msl is incorporated in section 2.4.7 (page 2.4-13) of the enclosed revision 2 of the ESP application.
