Indian Point Energy Center (IPEC) is submitting this response to NRC Inspection Report 05000247/2005010 and 05000286/2005008 (Reference 1). This inspection report documented the results of the inspection performed using Temporary Instruction (TI) 2515/164 and identified one unresolved item (URI). The unresolved item encompassed specific open elements related to ten of the thirty-four areas inspected. As requested in the transmittal letter for the inspection report 05000247/2005010 and 05000286/2005008, IPEC, as a member of the Entergy fleet, met with members of the NRC staff on February 2, 2006 to review the inspection report and determine what actions would be required to resolve each open element of TI 2515/164.
