Having said that, however, I have the facts and the law on my side, and I shall not yield. But I have to consider my despondent family first. It will take at least eight-months to get my family life back together, and prepare my argument.

My argument will address the paramount issue: The Merits of the instant cases should be decided by the Atomic Safety and Licensing Board if the Court will Order the U.S. Nuclear Regulatory Commission to allow them to have the autonomy, authority and resources to rule on the merits of the cases without any political influence nor allowing any political objectives to cloud the issues or change the scope of the proceeding or be allowed to be introduced into the proceeding.
