SUBJECT: REQUEST FOR CONCURRENCE ON THE U.S. NUCLEAR REGULATORY COMMISSION'S DETERMINATION OF "NO EFFECTS" ON FEDERALLY LISTED SPECIES AND THEIR CRITICAL HABITATS RESULTING FROM THE APPROVAL OF A SOIL DECOMMISSIONING PLAN FOR RIO ALGOM MINING LLC'S URANIUM MILL FACILITY AT AMBROSIA LAKE, NEW MEXICO (TAC LU0078)

Dear Ms. Nicholopoulos:

We are requesting your concurrence, with our determination, that the potential impacts resulting from the approval of Rio Algom's *Soil Decommissioning Plan*, will have no significant effect on federally listed species and/or their critical habitats, or that any adverse effects have been adequately mitigated by the licensee. The proposed action will be a modification to Rio Algom's Source Material License (SUA-1473), to approve their proposal to implement a *Soil Decommissioning Plan*. Their plan would remediate soil impacts attributable to licensed activities. The supporting basis for our conclusion is contained within the Draft Environmental Assessment for the proposed License Amendment (Enclosure 1).

If you have any comments regarding the NRC's review of the Rio Algom site, please provide them within 30 days so they may be fully considered.
