Gentlemen,

During the VTC with Ellis Merschoff and Jim Dyer, Ellis indicated that the region should have all of the tapes provided by Dr. Harvin transcribed, if we had not already done so.

OI was in possession of transcripts for all of the tapes, some of which were made by Dr. Harvin and verified by an OI agent. However, in response to Ellis' direction, OI sent the tapes out to be transcribed by a court reporter. These transcripts should be received on or before August 10, 2004. It is OI's belief that the transcripts provided by the court reporter will not be any more detailed than the transcripts developed by Dr. Harvin and verified by the OI agent.
