Dear Mr. Link:

We have performed an initial review of your ISA Summary update for calendar year 2005, transmitted by letter REL:06:003, dated January 27, 2006. Based on this review, we have determined that Attachment B (Annual Update for Calendar Year 2005) does not meet the requirements of 10 CFR 70.72(d)(2), since it does not include a brief summary of all the changes. The guidance for this submittal is discussed in the Statement of Considerations that was published in Volume 65 of the Federal Register at the time the New Part 70 was issued.

Specifically, the submittal should be modified to include a description of the change, the reason for the change, and why the change did not require pre-approval. The revised table should be submitted within 30 days from the date of receipt of this letter.

We intend to review the annual updates as part of the ISA Summary review. This action has been assigned Technical Assignment Number (TAC) L31929. Please reference this TAC number in any future correspondence associated with review.
