CALLAWAY PLANT, UNIT 1/WOLF CREEK GENERATING STATION

On August 14, 1984, Union Electric Company and Kansas Gas and Electric Company met with the appropriate NRR Assistant Directors to appeal the staff's position on their safe shutdown analysis. The meeting resulted in the staff and the utilities agreeing that the problem may not be as severe as originally believed and to hold a meeting between the cognizant reviewers and utilities today to discuss the issue. to describe the compensatory measures that will be in place to ensure that the plant meets all the applicable regulatory requirements until any 'tional modifications which may be needed are complete. Based on this it v 'luded that an appeal decision was not needed. If the problem still cannot resolved by the reviewers, the utilities will continue to pursue the appeal with the Assistant Directors.
