This notice is being sent to interested stakeholders to announce the availability of a draft of the proposed rule to update 10 CFR Part 52, "Licenses, Certifications, and Approvals for Nuclear Power Plants," on the NRC's rulemaking Web site at <http://ruleforum.llnl.gov>, under "Draft Rule Text for Comment." **This draft is an advanced version of the *Federal Register* notice that is expected to be published on March 13, 2006, and is being posted early to facilitate discussion at the NRC's upcoming public workshop on the rulemaking on March 14, 2006.**

This revised proposed rule supersedes the Commission's July 3, 2003 (68 FR 40026), proposed rule on 10 CFR Part 52. Comments on the proposed rule will be accepted for 75 days following the publication date of the proposed rule in the Federal Register.
