Amir,

I was able to discuss the time table for delivery information discussed in the action items in the 1/24 meeting report with our consultant.

Mallinckrodt will provide responses for RAIs #41, #44, and #49 in two weeks, and will review the DP and provide any changes or clarifying comments to the DP in 60 days.

We will continue to work with staff on the resolution of RAI #51 as well as to gather generic information that may be needed for the EA as indicated to us by staff.

At the time of the meeting, it was Mallinckrodt's understanding that the USACE would provide information concerning its position concerning clean up boundaries by the end of January. But, the USACE has not yet released that information which is required to finalize that aspect of the DP. Mallinckrodt will remain in contact with the USACE concerning this issue.

Last year the NRC submitted to Mallinckrodt approximately 100 RAIs for which responses were provided. The majority of these RAIs have been resolved.

Mallinckrodt is committed to working with staff to resolve the remaining RAIs, to finalize the DP, and to take other reasonable action to move the decommissioning process forward.
