## Making Spirits Bright – NMP Donates 350 Gifts!

For 10 years, Nine Mile Point employees have made the holidays brighter for children and seniors in Oswego County through the Giving Tree gift giving campaign. In most cases, we fail to follow procedures because we believe we know what the procedure says and, therefore, do not take the time to review and verify. I know first hand how important it is to understand the contents of procedures and, when in doubt, seek clarification.

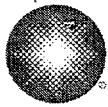
As the fire protection supervisor in 2000, I fell into the trap of not verifying site procedures. I was unclear of the requirement in the fire drill procedure and as a result mislead personnel and violated site procedure. The drill was compromised and deemed unsatisfactory due to my failure to verify the requirements in the procedure.

Needless to say, the lessons I learned were significant. The extra time it would have taken to verify the requirements in the procedure would have been far more valuable than acting on assumption. I wanted to share my experience with you to emphasize that each of us need to take the time to review, verify and follow procedures. It only takes a few minutes to verify standards and expectations and prevent events at Nine Mile Point.
