We wish to apply for an amendment to the above referenced license for the purpose of designating a new RSO. The new RSO is Joseph Kreitzer, who has been employed by the American Red Cross for 13 years, and has been an authorized user of the blood irradiator for 12 years. Joe is well trained for this position by virtue of completing the manufacturer's training course, having gone through numerous radiation safety training seminars provided by the Radiation Physics Consultant, and his years of operational experience in using the irradiator. Joe has completed a formal Radiation Safety Officer course in January, 2006, which consisted of 24 hrs of didactic instruction in radiation safety, held by Applied Health Physics, Inc. His certificate of attendance is attached. His educational background also supports this appointment; he has an Associate Degree.



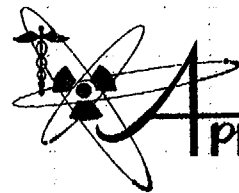

Effective with the receipt of amendment to U.S. Nuclear Regulatory Commission Materials License, License number 37-30073-01, Joseph Kreitzer will assume the duties of Radiation Safety Officer for the American Red Cross Blood Services, Northeastern Pennsylvania Region. Raymond Murphy, Hospital Services Technician II will also assume the duties of on-site assistant radiation safety officer. Mr. Kreitzer is responsible for ensuring the safe use of the self-contained gamma blood irradiator as defined in the Northeastern Pennsylvania Region procedures and for facility compliance with the U. S. Nuclear Regulatory commission policies. The Radiation Safety Officer is responsible for managing the radiation safety program, identifying radiation safety problems, initiating corrective actions, and ensuring compliance with regulations.

As the Radiation Safety Officer, Mr. Kreitzer is hereby delegated the authority necessary to meet those responsibilities.
