

The purpose of this modification is to (1) extend the period of performance from February 28, 2006 to March 31, 2006 and (2) provide incremental funding in the amount of \$50,922.25 thereby increasing the obligated amount from \$1,004,020.82 to \$1,054,943.07. Accordingly, the contract is hereby modified as follows:

- (1) The extension is necessary for the NRC to have continuous maintenance support for the SNAP code.

Section F.6, Duration of Contract Period (MAR1987) Alternate 2 (MAR 1987), the paragraph is deleted in its entirety and the following paragraph is substituted in lieu thereof:

"This contract shall commence on April 23, 2003 and expire on March 31, 2006."

- (2) Section B.3, Consideration and Obligation-Cost Plus Fixed Fee (JUN 1988), paragraph (c), is deleted in its entirety and the following paragraphs are substituted in lieu thereof:

"c. The amount obligated by the Government with respect to this contract is \$1,054,943.07, of which the sum of \$959,039.15 represents the estimated reimbursable costs, and of which \$95,903.92 represents the fixed fee."

Cumulative Total of NRC Obligations: \$1,054,943.07

This modification obligates FY06 funds in the amount of \$50,922.25.

All other terms and conditions remain the same including the contract ceiling of \$1,054,943.07.
