

The purpose of this modification is to change the expiration date from March 15, 2006 to September 15, 2006 at no additional cost to the Government. This extension is necessary to allow the contractor to resolve inconsistencies found in the raw data retrieved from Westinghouse Corp. Accordingly the Contract is modified as follows

Section F.6 "Duration of the Contract Period (March 1987)" is deleted entirely and replaced with the following in lieu of:

"This Contract shall commence on September 30, 2004 and will expire September 15, 2006."
