

The purpose of this modification is to provide funding in the amount of \$75,000.00 hereby increasing the obligated amount from \$449,623.00 to \$524,623.00. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation-Delivery Orders (JUN 1988), the first sentence in paragraph (b) is revised as follows:

“(b) The amount presently obligated with respect to this contract is \$524,623.00.”

All other terms and conditions, including the ceiling amount of \$594,992.00 remain unchanged.
