

The purpose of this modification is to provide funding in the amount of \$149,623 hereby increasing the obligated amount from \$300,000.00 to \$449,623.00. Accordingly, the contract is hereby modified as follows:

Under Section B.2, Consideration and Obligation-Delivery Orders (JUN 1988), the first sentence in paragraph (b) is revised as follows:

“(b) The amount presently obligated with respect to this contract is \$449,623.00.”
