

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)
The purpose of this modification is to provide incremental funding in the amount of \$16,964.23, thereby increasing the total obligated amount from \$200,000 to \$216,964.23. Accordingly the contract is modified as follows:

Refer to section B.3, "CONSIDERATION AND OBLIGATION - COST PLUS FIXED FEE (JUN 1988) ALT 1 (JUN 1991)" paragraph "c" is hereby deleted in it's entirety and replaced with the following"
"C The amount currently obligated by the Government with respect to this contract is \$216,964.23, of which the sum of \$199,967.03 represents the estimated reimbursable costs, and of which \$16,997.20 represents the fixed fee"

All other terms and conditions remain the same including the contract ceiling of \$216,964.23.

Except as provided herein, all terms and conditions of the document referenced in Item 9A or 10A, as heretofore changed, remains unchanged and in full force and effect.
