The purpose of this modification is to exercise the 1st Option - Optional Period, in accordance with Section C.4 FAR Clause 52.217-9, Option to Extend the Term of the Contract (MAR 2000)," thereby extending the period of performance through November 30, 2006, and increasing the total amount of the contract and the obligated amount by \$436,959, from \$715,713 to \$1,152,672. In addition, this modification hereby incorporates by reference, the January 6, 2006, e-mail from Brenda Owusu, Owusu & Company, in which the right to the 60-day preliminary notification of the NRC's intent to exercise this option is waived. Accordingly, the contract is modified as follows:

1. Section B.4, CONSIDERATION AND OBLIGATION-FIRM-FIXED PRICE, is deleted entirely and replaced with the following:

"The firm fixed price of this contract is \$1,152,672. The amount presently obligated with respect to this contract is \$1,152,672.

2. Section B.6 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 2 (MAR 1987), is deleted entirely and replaced with the following:

The contract shall commence on December 1, 2004 and will expire on November 30, 2006. The term of this contract may be extended at the option of the Government for an additional three (3) one-year option periods.

3. All other terms and conditions of this contract remain unchanged.

A summary of obligations for this contract, from the award date through the date of this action, is given below:

Total FY06 obligation amount:	\$ 582,612.00
