14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)  The purpose of this modification is to provide incremental funding in the amount of \$23,733.75 to partially cover Final Invoice No. 70B dated 5/9/05 (current balance under contract at \$3,620.96 will cover remaining invoice amount). This modification will increase the obligated amount of the contract from \$588,177.01 to \$611,910.76. Accordingly, the contract is hereby modified as follows: Under Subsection B.3, "CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988), "paragraph (g) is deleted in its entirety and the following paragraph is substituted in lieu thereof: "(g) The amount currently obligated by the Government with respect to this contract is \$611,910.76." All other terms and conditions remain unchanged. A summary of obligations from the award date is: FY98: \$122,857; FY99: \$40K; FY2000: \$75,042; FY2001: \$120K; FY2002: \$123K; FY2003: \$95K; FY2004: \$12,278.01; and FY2006: \$23,733.75. Cumulative Total of NRC Obligations: \$611,910.76. This modification obligates FY2006 funds in the amount of \$23,733.75.
