The purpose of this modification is to (1) exercise the twelve (12) month option period under Task Order No. 16 in accordance with Section C.7 under the subject contract; and (2) provide incremental funding of \$10,000 for the option period. Accordingly, the task order is hereby modified as follows: 1. The second paragraph of the definitization letter is revised as follows: "The option period is hereby exercised by the Government in accordance with Section C.7 of the contract, for the period of March 1, 2006 through September 30, 2006, at an estimated cost of \$45,637.16." Funds in the amount of \$10,000 are hereby obligated for performance of this task order for the option period." All other terms and conditions of the subject task order remain unchanged. A summary of obligations is provided as follows: FY05 Obligations: \$25,500 and FY06 Obligations: \$20,000. Cumulative Obligations: \$45,500. This modification obligates FY06 funds in the amount of \$10,000.
