Licensees who submit incomplete, less detailed, or applications inconsistent with TSTF-423 can expect longer review times, requests for additional information, or LAR rejection.

Plants using Custom Technical Specifications (CTS) can expect a longer review time, as CTS inhibit NRC's ability to review TSTF-related LARs under this accelerated program.
