I would like to thank you very much for the hospitality of U.S. NRC headquarter and Region I office members and for all their efforts to arrange the visit of inspectors from the French Nuclear Safety Authority (ASN) from October, 26th to November, 4th, 2005.

The meetings organized and the joint inspection at Three Miles Island nuclear power plants led to very fruitful exchanges.

These meetings with U.S. NRC staff gave ASN inspectors the opportunity to benefit from the American approach in the field of occupational exposure. The broad sharing of information and the openness of discussions were particularly appreciated.
