Dan, Mr. Miller of MFG, Inc. has stated several times that he is not authorized by Exxon to negotiate on their behalf. If Mr. Miller is authorized to bind Exxon contractually please provide documentation of such and we will then negotiate access issues with him if that is Exxon's desire. I did ask Mr. Miller for a response from Exxon prior to today's meeting with NRC and have not received such. That lack of response prompted the letter to the NRC yesterday. Also to clarify, the document you should be in possession of contains bullet points for the basis of an MOU between Exxon and Boner's. The sole purpose of the MOU is to ensure Boner's that Exxon will reimburse for the costs and expenses we will incur while negotiating an agreement with Exxon. Dan, our desire here is to work our way through an evaluation and potential restoration program that addresses the situation on the ground. We need to work to develop a business relationship that will provide such. Judging from the tone of this earlier e-mail we have some work to do.
