Request to Revise Technical Specifications to  
Delete Reactor Trip System Function 11, Reactor Coolant Pump Breaker Position

Ladies and Gentlemen:

On March 8, 2005, Southern Nuclear Operating Company (SNC) submitted a Technical Specification (TS) revision request to eliminate the Reactor Coolant Pump (RCP) Breaker Position Reactor Trip Function. An additional letter was submitted August 16, 2005 to address a request for additional information.

Further evaluation by SNC has resulted in a change to the proposed design and implementation schedule to support the deletion of this reactor trip system function that will require a re-submittal of the TS revision package. The design schedule is best supported by the withdrawal of the current TS revision package under review by the NRC. Therefore, SNC hereby withdraws the subject TS revision package. SNC will advise the NRC staff of the proposed schedule to submit the revised TS revision request.

Mr. L. M. Stinson states he is a Vice President of Southern Nuclear Operating Company, is authorized to execute this oath on behalf of Southern Nuclear Operating Company and to the best of his knowledge and belief, the facts set forth in this letter are true.
