Dear Mr. Diaz:

This is in reference to your letter dated February 17, 2006 requesting to amend Nuclear Regulatory Commission License No. 52-25255-01. In order to continue our review, we need the following additional information:

1. In support of your request to authorize Dr. Alvarez de la Campa for materials permitted under 10 CFR 35.300, please provide one of the following, as applicable:
 - a. Previous license number (if issued by NRC) or a copy of the license (if issued by an Agreement State) on which the physician was specifically named as an authorized user for the uses requested;

OR
 - b. Provide all of the following:
 - (i) Description of the required work experience identified in 10 CFR Part 35.390(b)(1)(ii)(G). Specifically, provide statement using 313A documenting the minimum 3 supervised cases for each category listed in 35.390(b)(1)(ii)(G).
 - (ii) Written certification, signed by a preceptor physician authorized user, that the above training and experience has been satisfactorily completed and that a level of competency sufficient to function independently as an authorized user for the medical uses authorized has been achieved.
