This is your last set of instructions for the Oyster Creek Scoping Site Audit. There are 16 people from NRC HQ and ANL/PNNL that are traveling to the site for this audit. Additionally we will have five members of the State of NJ DEP and four people from a commercial contractor, Earth Tech, that will be working with us. Because of the number of people attending, it is important that people are where they are supposed to be and on time.

1. Personnel Attending:

Annex A provides a roster of personnel attending the site visit. If the information is incorrect or there is a change in your arrival or departure time from the time I have suggested, please let Harriet Nash know of the change as soon as possible.

2. Travel Plans:

You should have completed your travel plans. NRC personnel are expected to carpool to the site Tuesday morning. Suggested carpool travel plan is given in Annex A. NRC personnel should plan on 4.5 to 5 hours travel time from White Flint to the site.

ANL/PNNL personnel are to travel Monday afternoon to the Philadelphia Airport, travel by rental car to the Toms River, NJ area and be ready for opening ceremonies at the plant at 1300 hrs on Tuesday. ANL/PNNL personnel should plan on 3 hours driving from the Philadelphia Airport to arrival at Toms River, NJ.

3. Lodging and Food:

Per diem for Ocean County, NJ (after 1 Oct) is \$78/36/114. Note this is a change from the last version of these instructions. There are three motels that I would recommend:

Quality Inn, 815 Route 37, Toms River, NJ, 732-341-2400 should honor the government rate of \$76.00. A standard Quality Inn located on busy route 37, has a great breakfast (eggs and bacon) but no toast.

Island Beach Motor Lodge, 24th and Central Ave, South Seaside Park, NJ, 732-793-5400, they should be way under the government per diem. On the Ocean, right at entrance to Island Beach State Park.

Holiday Inn Toms River, 290 Route 37 East, Toms River, NJ, 732-244-4000, standard Holiday Inn, no breakfast, on busy Route 37 should honor Government per diem rate.

There are a lot of fast food restaurants in the area. The only decent restaurant near the plant is Charlie Browns, 443 S. Main Street (Rt 9), Lacy Township, north of the plant. Limited restaurants near Island Beach, many near and in Toms River.

Lunch at the site on 12 Oct will be catered by licensee. The cost will be between \$5.00 and \$10.00. Please bring cash. You are on your own for the rest of the meals. We plan to have a team building function on Wednesday evening 12 Oct 05 at the Island Beach Motor Inn.

4. Directions:

Use Figures 2.1, 2-2, and 2-3 of the ER for area and site maps. Detailed directions between the Airport, the plant, and the motel are contained in annex B.

5. Concept of Operation:

Annex C contains the detailed schedule of activities. Be advised that this schedule may be revised before we begin the audit and may also change during the audit. The plan is for people to travel on Monday and Tuesday 10 and 11 Oct 2005. National Lab personnel meet Tuesday at 0800 hrs at a location to be determined at the Island Beach Motor Inn. All personnel, NRC, Earth Tech, Lab and State of NJ will meet at the Oyster Creek Nuclear Plant site, in Building 12 at 1300 hrs on 11 Oct 05. See annex B for directions to building 12. Lunch Tuesday is on your own. It is important to be there on time, so plan accordingly. Remember traffic is always an unknown so leave yourself some time. We will have a short orientation then load up on busses and do a quick site tour which will include some offsite locations. We will then return to Building 12 where we will break up into groups. Wednesday and Thursday we will be conducting the audit in earnest. We plan to send people into the facility, see the intake and discharge up close, conduct a transmission line tour, boat tour, visit with local officials and generally do our thing. Friday, for most of us will be traveling.

7. Guidance and Policy:

Be on time or be early for all meetings. Dress for meetings at the site and with the licensee is casual; however, no jeans, no open toed or backless shoes, no tee shirts without collars and no Hawaiian shirts. Make sure you have the proper footwear particularly those of you going into the plant, on the boat or along the transmission lines. For those going on the boat tour expect to wear a life jacket, have foul weather gear, sunscreen, etc. For those going on the transmission line tour be careful of ticks (Lymes Disease common) and beware of Jersey mosquitos - insect repellent is advisable. Ties are OK but not required. No sport jackets. However, if you are going offsite to meet with local representatives or public, particularly in an office setting, you are expected to be in casual business attire, shirt and tie for men, equivalent for women. Anyone planning to use a camera see me. Do not take any pictures of the plant, particularly security towers without first understanding what the rules are. They will be discussed at the kickoff meeting. You may bring a camera with you to the kickoff meeting but do not attempt to bring a camera inside the protected area without first getting a camera pass. Remember you are representing the NRC.

Be sure to have a picture ID on your person. You will not be able to enter the protected area without a picture ID. Drivers license is preferred. NRC personnel can use their NRC badge. Lab and State Personnel may not be able to use their work ID, so bring a drivers license.

Lab team members are to be accompanied by an NRC representative in all official discussions with local, State and other Federal personnel. This also applies to commercial and non-profit organizations. Personnel attending as shadows (both from the lab and Earth Tech) are encouraged to participate but take the lead from the more experienced lab members and NRC staff. Be extremely careful about prejudging any aspect of the review. Remember we are collecting information and listening to peoples concerns. Any criticisms or concerns expressed by people or organizations do not require a response at this time.

QUALITY INN IS ON THE RIGHT BEFORE YOU CROSS THE GARDEN STATE PARKWAY AND ROUTE 9 AND THE HOLIDAY INN IS ON THE LEFT ON ROUTE 37 ABOUT 4 MILES PAST THE INTERCHANGE WITH THE GARDEN STATE PARKWAY.
