Dear Administrative Judges:

Pursuant to the Order issued in this docket on February 2, 2006, the parties were to submit written proposals regarding suggested specific locations for the limited appearance statement session and the evidentiary hearing, as well as a calendar, covering July - October 2006 inclusive showing those dates where they are not available due to prior significant commitments. This letter provides that information from the State of Vermont.

The Quality Inn can accommodate 150-200 people. The Latchis Theater can accommodate 750 people.




