**PURPOSE:** Pre-decisional Enforcement Conference to discuss three apparent violations of NRC requirements involving failures to: (1) properly secure radiographic exposure devices containing by-product material; (2) have at least two qualified individuals present at all times during radiographic operations; and (3) block and brace a package containing a radiographic exposure device. This last apparent violation appears willful. The apparent violations are described in NRC Inspection Report Number 030-29319/04-003.
