

The purpose of this modification is to:

1. Provide incremental funding in the amount of \$80,860.00, thereby increasing the obligated amount of the task order from \$305,000.00 to \$385,860.00.

Accordingly, the task order is modified as follows:

1. Under Subsection B.1 – Consideration and Obligation, paragraph (b) is hereby deleted entirely and replaced with the following:

 “...(b) The amount presently obligated with respect to this order is **\$385,860.00**. The Contactor shall not be obligated to incur costs above this ceiling/obligated amount unless and until the Contracting Officer shall increase the amount obligated. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk...”
