Dear Sir or Madam:

In response to the letter to the undersigned, dated April 17, 2006, from Ms. Penny Lanzisera, Acting Chief Medical Branch, Division of Nuclear Materials Safety, United States Nuclear Regulatory Commission ("NRC"), the undersigned submits this letter to amend the undersigned's original notification and request to amend License No. 29-30983-01 and 29-30289-02 (the "Licenses"), dated March 31, 2006 ("Original Letter").

As described in the Original Letter, Doshi Diagnostic Imaging Services of New Jersey, LLC, ("Purchaser") will acquire substantially all of the assets of Community Radiology, P.A. ("Community") and Regional Radiology, LLC ("Regional" and, together with Community, collectively, the "Sellers") pursuant to the terms of an Asset Purchase Agreement, dated as of February 17, 2006. A copy of the Asset Purchase Agreement was provided to you as Attachment A to the Original Letter.

Pursuant to the request set forth in the NRC's letter, Purchaser hereby agrees to abide by all constraints, conditions, requirements, and commitments previously agreed to by Sellers in connection with the Licenses. Purchaser further agrees to assume the responsibility for: (i) the clean-up of any residual contamination occurring as a result of the operation of the Sellers' facilities or the Sellers' provision of services, and (ii) continuing Sellers' commitments to abide by any existing corrective actions or enforcement actions imposed by the NRC against Sellers or its facilities.


In a telephone conversation with Nicole Gade, Esq., one of the attorneys representing Purchaser in connection with the transaction, Ms. Lanzisera of the NRC indicated that she was not aware of any pending or threatened corrective actions against Sellers or their facilities. To the extent possible, the undersigned requests written notice from NRC of any pending or threatened corrective action against Sellers or their facilities.

Although the transactions contemplated by the Asset Purchase Agreement are scheduled to close on or about April 26, 2006, the effective date of the actual change of control of Sellers' facilities is uncertain due to various other licenses and approvals that must be obtained by Purchaser before Purchaser can operate all such facilities itself. The undersigned will advise the NRC of the effective date of the change of control of Sellers' facilities as soon as possible.
