### MEETING SUMMARY

LICENSEE: ENTERGY NUCLEAR OPERATIONS, INC.

FACILITY: INDIAN POINT NUCLEAR GENERATING STATION, UNITS 2 & 3

SUBJECT: SUMMARY OF MARCH 28, 2006, PUBLIC MEETING WITH ENTERGY NUCLEAR OPERATIONS, INC. AND THE NEW YORK DEPARTMENT OF ENVIRONMENTAL CONSERVATION REGARDING THE SPECIAL INSPECTION TEAM REVIEW OF SPENT FUEL POOL LEAKAGE AND GROUNDWATER CONTAMINATION AT THE INDIAN POINT ENERGY CENTER

On March 28, 2006 at 6:00 p.m., a public meeting was conducted at **Crystal Bay on the Hudson, Peekskill, New York, between the** Nuclear Regulatory Commission (NRC), Entergy Nuclear Operations, Inc. (Entergy), and the New York State Department of Environmental Conservation (NY DEC). The NRC, Entergy, and NY DEC presented and discussed their assessments of the spent fuel pool leakage and groundwater contamination at the Indian Point site. **The meeting was attended by approximately 400 people and a partial list of the meeting attendees is attached.**

**The NRC presented the Special Inspection Team results regarding its review and assessment of the groundwater contamination.** Entergy presented its perspective on the stations' performance, acknowledged and agreed with NRC's assessment and provided information regarding planned actions. The NY DEC also presented its review and assessment of the groundwater contamination and Entergy's actions to date.

These presentations were followed by a question and answer period which lasted approximately four hours. Questions raised by stakeholders related to the special inspection results, the assessment of radiological consequences due to groundwater contamination, license renewal, emergency planning, and corrective actions.

The NRC staff responded to questions raised by members of the public and local media. Feedback forms submitted by the public following the meeting will be evaluated.
