## **Request for Additional Information**

**Route Approval Application (NRC No. 222)**

**Route: University of Florida to Savannah River Site**

By application dated April 20, 2006, the TLI Secured Transportation Services, LLC requested an approval of a route to transport spent fuel from University of Florida to Savannah River Site. This request identifies additional information needed by the U.S. Nuclear Regulatory Commission (NRC) staff in connection with its review of the application. This request describes information needed by the staff for it to complete its review of the application and to determine whether the applicant has demonstrated compliance with regulatory requirements.

1. Verify and re-submit the 24-hour emergency contact information provided along the proposed route from University of Florida to Savannah River Site.

The emergency contact information provided along the proposed route contains incorrect telephone numbers. For example, statewide emergency contact phone numbers were provided for each county in the states of Georgia and Florida. In both cases, the state contact informed the NRC staff that this phone number was incorrect and provided the NRC staff county level emergency contact numbers. In addition, one phone number was a personal cell phone number. The contact informed NRC staff that their personal cell phone number is not a 24-hour emergency contact. The 24-hour emergency contact information ensures that local law enforcement assistance is available while the spent fuel shipment is in transit in accordance with the requirements of 10 CFR 73.37.
