





This letter is to document the training in Nuclear Cardiology that was performed by Dr. Delair Gardi. From July 2000 through June 2003 Dr. Gardi was a Fellow in Cardiology at the University of Missouri-Columbia (affiliate hospital), and during that time I was his preceptor for training in Nuclear Medicine in general and Nuclear Cardiology in particular.

Dr. Gardi's training satisfies the ACC/ASNC COCATS guidelines for Specialized Training—Level 2. He achieved a level of competence sufficient to function independently as an authorized user for medical uses of radiopharmaceuticals described in 10CFR35.290. We read together more than 345 cases of myocardial perfusion imaging, and in more than 100 cases we correlated the findings with cardiac catheterization. Dr. Gardi completed a 200-hour course of classroom learning by the Institute for Nuclear Medical Education, Boulder, Colorado.

I highly recommend Dr. Gardi for the independent practice of Nuclear Cardiology and for entrance to the Certification Examination in Nuclear Cardiology.
