This is in reference to your letter dated April 20, 2006 requesting to amend Nuclear Regulatory Commission License No. 29-20960-01. In order to continue our review, we need the following additional information:

1. In order to add Dr. Kasatkin to the license as an authorized user, submit a signed preceptor statement as described in 10 CFR 35.290(c)(2). Preceptor forms may be found on the NRC website at:

2. The medical specialty boards whose certification process has been recognized by the NRC are listed on the NRC website. The CCNC certification is not recognized by the NRC and cannot be used as proof of qualification for Dr. Roberti. Therefore, in order to add Dr. Roberti to the license as an authorized user, submit documentation demonstrating compliance with 10 CFR 35.290(c)(1) and submit a signed preceptor statement as described in 10 CFR 35.290(c)(2). Preceptor forms may be found on the NRC website at: <http://www.nrc.gov/reading-rm/doc-collections/forms/nrc313a.pdf>.
