On January 1, 2005, the parent corporation of Jefferson Memorial Hospital merged with West Virginia University Hospitals, Inc. It is located at 300 South Preston Street, Ranson, West Virginia 25438. Jefferson Memorial Hospital is establishing a diagnostic nuclear medicine department under West Virginia University Hospitals, Inc., NRC license No. 47-23066-02. It will have the same Radiation Safety Officer (RSO) and the same Authorized Users (ARU) as West Virginia University Hospitals, Inc. Nuclear Medicine Department.

The Jefferson Memorial Hospital Nuclear Medicine Department has hired one full-time nuclear medicine technologist and is in the process of hiring another full time nuclear medicine technologist who will work under the supervision of the WVUH Authorized Users and it will be audited under the same, West Virginia Hospitals, Inc., license conditions.

Therefore, we are hereby requesting an amendment of our license to include Jefferson Memorial Hospital.
