Your letters to President Bush and Senator McConnell, dated April 20, 2006, regarding security measures at the Paducah Gaseous Diffusion Plant (PGDP) have been directed to the U.S. Nuclear Regulatory Commission (NRC) for a response. I am pleased to provide the following information which is relevant to your concerns.

On June 17, 2002, NRC issued a classified Interim Compensatory Measures (ICM) order to the United States Enrichment Corporation (USEC) regarding security measures at PGDP. USEC responded with revisions to its security program that NRC subsequently inspected and found to be adequate. On March 6, 2006, USEC submitted a request for revisions to its security program under the ICM order.

On April 11, 2006, NRC inspectors visited PGDP. The inspectors reviewed the existing security measures and found the measures to comply with the ICM order. In addition, the inspectors and USEC staff discussed the proposed revisions to security measures. On May 31, 2006, NRC issued a letter to USEC requesting extensive additional information regarding the requested changes. After NRC receives this information, the Office of Nuclear Security and Incident Response (NSIR) staff will perform a thorough review and determine the efficacy of the proposed measures from a security perspective. Unless the proposed changes result in a security level equal to or greater than the existing security posture, NRC will not approve the proposed changes.
