In your email dated June 12, 2006, you requested a record of the statements of Commissioner McGaffigan regarding Nuclear Information and Resource Service/Public Citizen's (NIRS/PC) involvement in the LES licensing case. I believe you are referring to statements Commissioner McGaffigan made concerning NIRS at a May 2, 2006, Commission briefing on emergency planning. Following this briefing, NIRS/PC requested that Commissioner McGaffigan disqualify himself from the LES proceeding. In the May 2, 2006, briefing Commissioner McGaffigan did not make any statements regarding the LES licensing case.
