On June 2, 2006, the Nuclear Regulatory Commission (NRC) issued, "Final Significance Determination for a White Finding (Safeguards Inspection Report 05000272/2006008, 05000311/2006008, and 05000354/2006006) – Salem and Hope Creek Generating Stations." In this report, the NRC also issued a Notice of Violation regarding an apparent violation of Salem-Hope Creek Physical Security Plan.

PSEG Nuclear LLC, (PSEG), provides its response to the Notice of Violation in the attachment to this letter.
