License Amendment Request - Change in Storage Location

This letter is being submitted to inform the Nuclear Regulatory Commission that Civil & Environmental Consultants, Inc. (CEC) is proposing to change one of the licensed storage locations associated with License No. 37-28465-01. The Indianapolis, Indiana branch of CEC is relocating and will have on-site storage available at the new location. The storage location that CEC would like to have removed from our license is:

CEC has reviewed the leak testing results for testing performed during the time period in which nuclear density gauges were stored at this location, and none of the sample activities were reported to have been equal to or exceed 0.005 μ Ci, therefore no additional measurements post gauge relocation are planned.


