SUMMARY

We have reviewed your two letters, both received April 3, 2006, and your fax dated April 27, 2006, requesting an amendment to your byproduct materials license and find that we need additional information as follows:

1. In accordance with your fax dated April 27, 2006, we assume your intention was to withdraw Mark DeWeese, M.S. as a proposed RSO. In addition, I reviewed your request to name Jim Smith, M.S. as your proposed RSO.

It does not appear that Mr. Smith can be approved as RSO for your license, based upon the information provided thus far. He does not appear to qualify under 10 CFR 35.57 and he did not present credentials that qualify him under 10 CFR 35.50 and 35.59. The excerpts from other licenses that show him listed as RSO were incomplete and did not show the dates when they were signed by the regulatory authority that issued the amendments so I could not determine whether Mr. Smith qualified under 10 CFR 35.57 or not.

Please submit appropriate information, in accordance with the guidance that follows, to support Mr. Smith's application to become RSO for your license.

You may refer to the above sections in 10 CFR 35 and NUREG 1556, Vol. 9, Rev. 1, Section 8.10, Item 7, and Appendices B, D and E for assistance. These documents are accessible on our website at <http://www.nrc.gov>. Then click on the "Nuclear Materials" toolbar key and the "Medical Use Licensing/Part 35" option on the Quick List.

Please do not submit resumes, CV's, or personal, proprietary information that we must protect, in accordance with 10 CFR 2.390, such as social security numbers, dates of birth, home addresses or phone numbers, patient records, college transcripts, etc.

Please be reminded that a new training and experience rule became effective April 29, 2005, which changed the regulatory requirements for RSO's and other users from those in effect from 2002 - 2005.

Also, please do provide a date on all correspondence provided to us.

We will be unable to continue processing your request until we receive this information.

Please also be reminded of the provisions in 10 CFR 30.9(a), "Completeness and accuracy of information,"...(a) Information provided to the Commission by an applicant for a license or by a licensee or information required by statute or by the Commission's regulations, orders, or license conditions to be maintained by the applicant or the licensee shall be complete and accurate in all material respects."

If we do not receive an adequate response by this date, we will partially issue those requests made in your letters that are ready for amendment and you may respond to the RSO deficiencies at a later date. **However, please be reminded that 10 CFR 35.24 requires you to have a qualified RSO on your license at all times.** Upon receipt of your response we will reactivate placement of your request in our database and resume our review. Address your written response to my attention at the above address.
