NOTICE OF WITHDRAWAL OF APPLICATION FOR

AMENDMENT TO FACILITY OPERATING LICENSE

The U.S. Nuclear Regulatory Commission (the Commission) has granted the request of Nuclear Management Company (the licensee) to withdraw its July 25, 2005, application for proposed amendment to Facility Operating License No. DPR-22 for the Monticello Nuclear Generating Plant (MNGP) located in Wright County, Minnesota.

The proposed amendment would have revised the MNGP Technical Specifications, adding direction to plant operators for when an Emergency Service Water subsystem is inoperable.

The Commission had previously issued a Notice of Consideration of Issuance of Amendment published in the FEDERAL REGISTER on December 20, 2005 (70 FR 75493). However, by letter dated June 23, 2006, the licensee withdrew the proposed amendment.
